Judicial Services is dedicated to enhancing the quality of life in Lake County by offering life skills programs for the 19th Judicial Circuit Court. These programs include the National Safety Council's Defensive Driving Courses, a course for divorcing parents of minor children and coordination of volunteers for the Adult and Juvenile Probation Program among others.

DRIVER SAFETY PROGRAM

Invest in the safety of your family and others by enrolling in our award-winning National Safety Council Defensive Driving Courses. Courses are designed for court supervision ticket reduction and personal safety education.

- Learn defensive driving concepts, including rules of the road, collision prevention tactics and the everyday driving situations motorists face.
- Teens and senior citizens may be eligible for reduced auto insurance premiums after taking a class.
- Classes are offered at five convenient locations and online.
- Five programs available, including Alive at 25.
- Classes offered in English and Spanish. ASL interpreters provided upon request
- Upon successful completion, you will receive a certificate of completion.

Alive At 25 Courses

Driving or riding in a motor vehicle is the most dangerous activity a teen can do. According to the National Safety Council:

- Vehicle crashes are the number one cause of death for people between the ages of 16 and 24.
- More than half of teens killed in car crashes are not restrained by a safety belt.
- Teens are three times as likely to crash as more experienced drivers.

Addressing this threat, Judicial Services offers the National Safety Council's Alive at 25 Defensive Driving course targeted to teen drivers. The highly interactive program focuses on the issues that put teen drivers in jeopardy while providing suggestions for becoming safe and responsible drivers.

TEEN ALIVE AT 25 PROGRAM –VOLUNTEER

In this four-hour course designed for teens from 16 to 20 years of age, students learn how to take responsibility for their driving behavior. This program is geared toward high school students who want to improve their driving skills. The sessions are highly interactive, using media segments, group discussions and role playing. Teens learn how to develop strategies that keep them safe on the road.

OTHER PROGRAMS

Live Victim Impact Panels

This course is designed for those convicted of DUI or similar offenses. The panel is composed of individuals whose lives have been impacted by a drunk driver. These individuals share their stories in the hope that those in the audience will gain an increased awareness of the serious consequences of drinking and driving. This course is offered once a month on the CLC Grayslake Campus.

Family Parenting Program

Designed for divorcing couples with minor-aged children and those with post-judgment petitions, this four-hour course looks at custody and related issues from the perspective of a child. Classes are held on an ongoing basis at CLC's Grayslake, Lakeshore and Southlake Campuses.

Behavioral Choice Module – Juvenile and Adult

This four-hour course is designed to provide juveniles and adults with ordinance violations strategies to look at their behavior and how to make better choices in the future. This course is based on the concept of restorative justice philosophy addressing thinking errors using the COG (Thinking for a Change) model. The core components of COG are public safety, accountability and competency development.

Substance Abuse Module (SAM)

A four-hour course provides an educational approach to drug and alcohol abuse. It is designed for teens and young adults with ordinance violations of minor possession of alcohol or cannabis, paraphernalia and other related charges. The course demonstrates physical and mental impairments from alcohol and other drugs, emphasizes responsibility and consequences of students' behaviors, how to handle peer pressure and making better personal choices.
