Step 1

Failure to carry proof of insurance

A person receiving a traffic ticket for *failure to carry proof of insurance*, may avoid going to court by appearing at the Office of the Circuit Clerk with proof that the vehicle was insured at the time the ticket was issued.

To use this procedure you must:

- 1. Appear at the Circuit Clerk's office listed at the bottom of your ticket, no later than (1) day before your court date listed on your ticket.
- 2. Bring valid proof of insurance.
 - Original documents only. No copies.
 - Shows effective and expiration dates of policy.
 - Shows the make, model and year of vehicle.

★ Must show that vehicle was insured at time ticket was issued.

Valid proof includes any (1) of the following.

- Vehicle insurance card.
- Certificate of insurance
- Declarations page of the insurance policy.
- Letter from your insurance company.

If you provide proper documentation and sign the affidavit required by the Clerk, the Failure to Carry Proof of Insurance ticket will be dismissed. If you wish to appear in court on the Failure to Carry Proof of Insurance charge, simply appear on the date, and at the time and place listed on the ticket.

If you have a traffic ticket and wish to request Driver Safety School, proceed to Step 2.

Step 2 - Read all information completely

Read this if you wish court supervision and to attend driver safety school without going to court.

Are you eligible for Driver Safety School?

You are eligible to receive Court Supervision without coming to Court:

- If you have not had court supervision or have not attended or enrolled in Driver Safety School for any violation committed within the previous twelve months from the date the current ticket was issued. "Committed" means the date the previous ticket was issued.
- 2. **If you are willing to plead guilty** on the traffic ticket, request court supervision and pay the prescribed fine, costs and fees for such violation.
- 3. **If you are found ineligible**, a conviction will be reported to the Secretary of State. **The fees will not be refunded.**

Payment

A non-refundable payment for the ticket, related court cost and class fee is required. There are both instructor-led and Internet course options. Please see "select your payment" in step 5 on the registration form for payment choices.

Driver Safety School Registration

To register for Driver Safety School mail the following items in the enclosed envelope no later than fifteen (15) days before the court appearance date written on the bottom of your ticket.

- 1. The signed Application for Court Supervision with a plea of guilty Step 4.
- 2. The completed Registration Form Step 5.
- 3. The signed "blue copy" or "Plea of Guilty and Waiver" on your ticket.
- 4. A money order OR bank certified check made payable to the Clerk of the Circuit Court of Lake County. **All fees are non-refundable.**

No personal or business checks - do not send cash!

Rescheduling Information:

- You may reschedule a class up to 48 hours prior to the class date once at no charge. Each additional rescheduling fee will be \$15.00.
- Failure to appear in class without notifying the Driver Safety School office (847-543-2185) before the class date will result in a charge equal to the amount of the class to reschedule.

Driver Safety School Participation

Your class assignment will be mailed to you. Class locations are subject to change. Your request will be honored if possible.

It is your responsibility to notify the Driver Safety School if you change your mailing address. The Driver Safety School is not responsible for late, lost, and/or undeliverable mail.

Successful Completion

If eligible, you will successfully complete Court Supervision *without* coming to Court:

- 1. If you pay all fines, costs and fees; and
- 2. *If* you successfully complete the four (4) hour Driver Safety School within the specified time of your Court Supervision period; *and*
- 3. If you do not receive any additional traffic violations during the Court Supervision Period, which is approximately 120 days from the court date listed on the ticket.
- 4. The Court will be notified of your completion. No conviction will be reported to the Secretary of State.

Please turn over to continue registration process.

Important Reminder: Driver Safety School must be completed 30 days before the court supervision completion date that will be approximately 120 days from the court date written on the bottom of your ticket.

Begin Here

Read completely to understand your options.

You may be able to avoid going to court.

- 1. If you have a *failure to carry proof of insurance* ticket, follow the directions in Step 1 at the top of the page.
- 2. If you have a traffic ticket, follow the directions below. You have 3 options in which to dispose of a traffic ticket. Options 1 and 2 are detailed on the back of the traffic ticket.Option 1: Plead guilty and pay the fine in person or by mail without going to court or
 - **Option 2:** Plead not guilty, request a trial and appear in court *or*If you wish to choose Option 1 or 2 read and follow the directions on the reverse side of your ticket. *Do not use this document.* The Clerk of the Court cannot give continuances or new dates over the telephone.
 - **Option 3**: Plead guilty, request supervision, and attend **Driver Safety School.** If you wish to choose Option 3 follow the directions in Step 2.

Driver Safety School

Driver Safety School classes are designed to improve decision-making skills, decrease the possibility of future violations, and reduce the possibility that you or someone else will be killed or injured in a traffic collision.

CDL holders are not eligible for court supervision.

Violators under 18 must appear in court with a parent or legal guardian. Do not use this form.

Legal Advice

If you have questions on the law, you may wish to consult with an attorney and obtain legal advice. The Office of the Circuit Clerk, the Police Department issuing this ticket, and the Driver Safety School will not give you legal advice.

- 3. Failure to appear in class without notifying the Driver Safety School office (847-543-2185) before the class date will result in a charge equal to the amount of the class to reschedule.
- 4. Notification of class completion will not be given to the Court until all fees are paid.
- 5. Upon successful completion of the class, the Driver Safety School will notify the court. No driving conviction will be reported to the Secretary of State.
- 6. Failure to complete class within the time allotted for supervision will result in a conviction being reported to the Secretary of State.

It is your responsibility to notify the Driver Safety School if you change your mailing address. The Driver Safety School is not responsible for late, lost, and/or undeliverable mail.
