BEGIN YOUR REAL ESTATE CAREER

Broker Requirements

Candidates must meet all of the following requirements to qualify for an Illinois Real Estate Broker's license under IDFPR Category A that states applicants must: 1) Be at least 18 years old; 2) Have graduated from high school or obtained the equivalent of a high school degree (GED); and 3) Have successfully completed the required curriculum of 90 class hours of Real Estate courses at a real estate school approved by the Illinois Department of Financial and Professional Regulation. PRLE 2 and PRLE 3 satisfy the course requirements for Category A., are approved by IDFPR and allow an individual to be eligible for the Illinois Real Estate Broker Examination. PRLE 2 (Live) and PRLE 3 (Live) classes require attendance for all class hours and the PRLE 2 (Online) class requires a score of 75% or higher on the class final exam to pass the course and receive a Uniform Real Estate transcript.

BROKER PRE-LICENSING TOPICS

This course, with the Broker Pre-Licensing Applied Principles course (PRLE 3), fulfills the new education requirements for obtaining an Illinois Real Estate Broker license. You are required to attend all sessions which include: introduction to the license law and real property; basics of agency, seller and buyer relationships and counseling; brokerage, marketing and advertising; market analysis and appraisal; financing, contracts, independent contractor and employee status, occupational disciplines and business planning.
