

# BUSINESS STARTUP CHECKLIST

Use this checklist to begin working with the Illinois Small Business Development and International Trade Center at College of Lake County and ensure your efforts to start a business are successful. Registration is the first step to working with the SBDC-ITC.

## SBDC Registration and Startup Advising

- Required:*** Register as a client with the Small Business Development & International Trade Center (SBDC-ITC) at College of Lake County.
- Strongly Recommended:*** View the 1-hour, online [Starting Your Business in Illinois](#) presentation to learn the basic elements of a successful business startup.
- [Schedule a one-on-one advising session](#) with an SBDC advisor that specializes in startup advising.

## Basic Startup Resources

- [Join the no-cost BizHub community](#), which connects businesses to critical success resources.

## Business Registration, License, and Regulations

- Determine the best legal entity to form for your business. Explore the [Starting Your Business in Illinois Handbook](#) and BizHub for assistance forming a legal entity.
- [Form a legal entity](#) with the Secretary of State.
- [Get an Individual Taxpayer Identification Number \(ITIN\)](#) if you do not have a social security number and an [Employer Identification Number \(EIN\)](#) to register your business and pay taxes.
- [Complete an Illinois Business Registration form](#) to register with the Illinois Department of Revenue.
- Consider the need for commercial liability insurance and purchase coverage if applicable. Explore BizHub for commercial insurance providers.
- Contact your local village hall for information about licenses, permits, parking, restrictions, signage requirements and more. Explore BizHub for information about your local village hall.
- [Work with the Lake County Health Department](#) to receive training and permits for food related businesses.
- [Complete an Assumed Business Name Form](#) from the Lake County Clerk's office.

## Business Finance and Accounting

- Calculate startup costs using Small Business Administration (SBA) resources.
- Explore BizHub for business funding sources.
- Establish a commercial banking account. Explore BizHub for commercial banking options.
- Provide for accounting and tax preparation needs. Explore BizHub for accounting and tax providers.
- Obtain a Sales and Use Tax Permit if applicable.

## Business Training

- Register for TAD (Training/Assessment/Development) platform, which provides a wide variety of training and skill building programs. This online tool is currently provided at no-cost.
- Attend no-cost and low-cost training programs to strengthen your skills in a wide variety of areas. Important startup topics include Startup & Planning, Marketing & Sales and Accounting & Finance.
